1	Introduction and update from the Chair	
	Chairs update IP reported that he had attended an introduction to the New Care Act in York, by Luke Clements another carer had also attended the update .There were 2 sessions, IP had only attended one, had found it very helpful and interesting. 	 Confusion on the minutes of the November meeting over initials as Alayne Holmes and Avril Hunter have the same initials .Avril was clear that she was responsible for the actions that had the initials AH and AV against. Updating emergency cards, carers voiced concerns that information held in NYCC data base for emergency support could be out of date and that staff are not updating this info at reviews .Also do A and E departments know to access NYCC to establish who will care for the cared for person if they main carer is taken ill etc. Currently updating the carers leaflets and flyer in line with the Care Act Issues around accessing forms for Blue Badges /Benefits need some clarification. HG asked if the "Checkers " idea she talked about in the November meeting had been discussed by senior management ,this needs to be followed up . Minutes agreed as a true record. 			
3	Workshop			
	SC and AV introduced the Workshop , Notes will be provided from the workshop Main areas discussed where Re Looking at the Terms of Reference for the group What the forum is for ? What is working well/less well? Who else should be involved in the discussions Next steps. Good progress was made in the workshop carers felt engaged in the process and that they were being listened too. It was also decided that an Action Log should be produced after every meeting to ensure that all work that needs to happen from the, meeting is captured and acted upon.			
4	Care Act			
	SC and AV asked the group to have a look at the new draft "Landing Page " that cares will come to online before they complete the Impact of Caring form. That is if they chose to complete it on line. The group discussed the document and recommended some changes .The words Eligibility and Assessment caused the group some concern but as they are			

	formal terms mentioned in the Care Act, NYCC need to include them in their information. The group also suggested comments from cares around the benefits of the assessments and the carers grant would give new carers more understanding around the process, coupled with examples of support plans to show how carers can benefit .This will help paint a more real picture for them . SC also mentioned a need for reading group where information can be emailed out to carers for their views and opinions.
