PANEL VIEWS

- 6. The Panel would like to thank you and your colleagues for the helpful responses provided to Members' questions during the meeting. Members found the presentation of the draft report accessible and useful discussions were generated to further clarify on or further explore aspects of the content.
- 7. Members were particularly keen to obtain further detail around the York Priorities listed, which indicated a steep decrease in anti-social behaviour (-32%) and a 32% increase in violence. Members asked the Commissioner if it would be possible to understand what percentage of violent crimes were linked to violence against women and girls and we would be grateful for any further information that can be provided to us.
- 8. There were additionally a couple of further points requiring clarification as raised in the meeting, which are outlined below:
 - The number of police officers on page 18 (from Home Office figures) at December 2021 were 1,563. However, page 28 highlights that numbers of officers are "now in excess of 1,600".
 - Page 18 of the draft report refers to the police officer uplift programme providing a means of enhancing diversity in the service, particularly in areas such as the firearms department, which the report states has traditionally struggled to recruit a diverse workforce. Members queried whether it would necessarily follow that there would be a diversity of recruited officers directly into firearms as this is a more specialist area.
- 9. Overall, Members feel that the report provides a helpful overview of the key issues and achievements over the past year and, on the basis that further information can be provided for Panel on the above queries, I am happy to confirm the North Yorkshire Police, Fire and Crime Panel's support for your Policing and Crime Annual Report 2021-22.
